

**NEW COUNTRY 96.3'S "TEXT TO WIN WEEKEND (DECEMBER 11-12, 2021): HOLIDAY HOEDOWN +  
ANDRETTI KARTS AND INDOOR GAMES" CONTEST  
OFFICIAL RULES**

The Station will conduct the **New Country 96.3's "Text to Win Weekend (December 11-12, 2021): Holiday Hoedown + Andretti Karting and Indoor Games"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

**Eligibility.** This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 day, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 days. **Void where prohibited by law.** Employees of Station, WBAP-KSCS Assets, LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest entry period will begin at 10:00am CT on December 11, 2021 and will run through 6:59pm CT on December 12, 2021 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.**

**On-Air/Text:** Listen to the Station each day during the Contest Period for the keyword to text. Send a text message with the announced keyword, spelled correctly, to 68255. All entries must be received by 7:59pm CT on December 5, 2021 to be eligible for a chance to win a prize. One (1) different keyword will be announced each hour during the below listed timeframes for a total of four (4) different keywords throughout the Contest Period.

Announce Timeframes:

- Saturday, December 11, 2021 | 10:00am CT - 11:59am CT; 12:00pm CT - 1:59pm CT; 2:00pm CT - 3:59pm CT; 4:00pm CT - 5:59pm CT; 6:00pm CT - 7:59pm CT; and 8:00pm CT - 9:59pm CT.
- Sunday, December 12, 2021 | 10:00am CT - 11:59am CT; 12:00pm CT - 1:59pm CT; 2:00pm CT - 3:59pm CT; and 4:00pm CT - 5:59pm CT.

Each keyword will be announced a minimum of three (3) times on Saturday and a minimum of two (2) times on Sunday, for a minimum of five (5) times throughout the Contest Period. Keywords must be received by the end of the Contest Period to be eligible to participate in the prize drawings. **Message and data rates may apply. Station has no responsibility for any fees or charges associated with any**

**text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number per keyword.**

4. **Winner Selection.** On or about 10:00am CT on Monday, December 6, 2021, Station will select four (4) potential winners in a random drawing from among all valid entries received by Station during the Contest Period to receive the prize in a random drawing from among all valid entries received by Station during the Contest Period to receive the grand prize, as detailed below. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Unclaimed prizes may not be awarded.

The winner will receive two (2) tickets to Holiday Hoedown at the Texas Trust CU Theatre in Grand Prairie, TX Saturday, December 18, 2021 and two (2) Andretti Indoor Karting and Games experience passes. The approximate retail value ("ARV") of each prize is two hundred forty dollars (\$240.00).

**TOTAL ARV OF ALL CONTEST PRIZES IS: NINE HUNDRED SIXTY DOLLARS (\$960.00).**

Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning a prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

There is no substitution, transfer, or cash equivalent for prizes, except that the Station may, in its sole discretion and to the extent permitted by law, substitute prizes of comparable value or cash. Any tickets and/or gift certificates/cards awarded as part of a prize will be subject to the terms and conditions set forth by the issuer and are valid only on the date(s) printed on the tickets or gift certificates/cards. Other restrictions may apply.

If any prize or a portion of any prize is postponed, cancelled, or otherwise unavailable due to disease, epidemic, pandemic, quarantine, any acts of government and/or any reason that is beyond the control of

Station or any Sponsor, then no substitution shall be provided. Station and any Sponsors make no representation or warranty about the safety of any prize. By accepting and using a prize, each winner acknowledges and assumes all risks of accepting and using the prize, and any other risks associated with the prize.

Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Contest or receipt or use, non-use or misuse of any prize.
