

**NEW COUNTRY 96.3'S "COOL DOWN IN THE CAYMAN" CONTEST
OFFICIAL RULES**

A complete copy of these rules can be obtained by contacting radio station KSCS-FM ("Station"), 3090 Nowitzki Way – Suite 400, Dallas, TX 75219, during available business hours Monday through Friday, on the Station website www.newcountry963.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **New Country 96.3's "COOL DOWN IN THE CAYMAN"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age twenty-one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **30 days** and whose immediate family members or household members have not won a prize from the Station in the last **30 days. Void where prohibited by law.** Employees of Station, WBAP-KSCS Assets, LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest entry period will begin at 3:00 pm CT on Friday, August 25, 2023, and will run through 7:00pm CT on Friday, September 1, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter:**

- (i) **Remote Broadcast:** Attend a remote broadcast conducted by the Station as described below and complete an entry form. **Limit one (1) entry per person per remote broadcast.** All entries must be received by the deadline stated at the remote broadcast. Station will select one (1) qualifying winner from the remote broadcast.

- (ii) **On-Air:** Listen to the Station weekdays at around 9:30am, 1:30pm, and 5:30pm CT during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 888-787-1963. Caller nine (9), or any other number announced at the time of the cue-to-call, to the Station, as determined by the Station in its sole discretion, will be eligible to win the qualifying prize for that Selection Day and will be eligible to enter into a grand prize drawing after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. **Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:** Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the

Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. **LIMIT ONE PRIZE PER PERSON.**

(iii) **Online:** Visit the Station's website www.newcountry963.com during the Contest Period, click on the "Contest" link, click on the "Cool Down in the Caymans" Contest link, and complete an entry form. All entries must be received by 7:00pm CT on Friday, September 1, 2023 to be eligible for the Grand Prize drawing. **Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use.** Multiple participants are not permitted to share the same email address. Any attempt by any participant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the participant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the participant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted. Station will select one (1) qualifying winner from the online contest.

4. **Grand Prize Winner Selection.** On or about 12:00pm CT on Tuesday, September 5, 2023, Station will select one (1) potential winner in a random drawing from among all valid qualifiers received by Station during the Contest Period. The winning qualifier will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.
5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. In the event that the

potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Unclaimed prizes may not be awarded.

6. **On-Air Qualifying Prizes.** Fifteen (15) qualifying prizes will be awarded in this Contest. Each winner will receive: two (2) tickets to see Zach Bryan @ AT&T Stadium on Saturday, August 17, 2024.

Online and Remote Broadcast Qualifying Prizes. Two (2) qualifying prizes will be awarded in this Contest, one (1) from the Online Contest and one (1) from the Remote Broadcast. Each winner will receive: two (2) tickets to see Russell Dickerson @ South Side Ballroom on Saturday, November 4.

The approximate retail value (“ARV”) of each qualifying prize is One Hundred Dollars (\$100.00).

TOTAL ARV OF ALL QUALIFYING PRIZES IS: ONE THOUSAND SEVEN HUNDRED DOLLARS (\$1,700.00).

Grand Prize. One (1) grand prize will be awarded in this Contest. The winner will receive: a trip for (2) two for a four (4) night / five (5) day trip to Grand Cayman, roundtrip air transportation on American Airlines for two (2), ground transportation to and from the airport and hotel in the Cayman Islands, double occupancy hotel room at the Westin Grand Cayman Seven Mile Beach Resort and Spa and an Excursion to Sting Ray City.

The ARV of the Grand Prize is Four Thousand Dollars (\$4,800.00).

TOTAL ARV OF ALL CONTEST PRIZES IS: SIX THOUSAND FIVE HUNDRED DOLLARS (\$6,500.00).

Winner and guest must travel on the same itinerary. Winner and Guest must have valid Passports, trip cannot be taken on a passport with 6 months or less validity on them. Winner’s guest must be twenty-one (21) years of age or older. Grand Prize Trip is non-transferable and no substitution will be made except as provided herein at the Station’s sole discretion.

10. **General Conditions.** Station reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failures or any other factor beyond Station’s reasonable control impairs the integrity or proper functioning of the Contest, as determined by Station in its sole discretion. Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station’s failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant’s participation in the Contest or receipt or use, non-use or misuse of any prize. No more than the stated number of prizes will be awarded. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.

12. **Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. **SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

All entry blanks, forms, devices, and materials gathered during the course of entry, as well as all information contained therein, shall become the sole property of Station to be used, disposed of or destroyed in its sole discretion. Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
