# NEW COUNTRY 96.3'S "THE AMERICAN WESTERN WEEKEND WINNING WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KSCS-FM ("Station"), 3090 Nowitzki Way, Dallas, TX 75219 during available business hours Monday through Friday, on the Station website www.newcountry963.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **New Country 96.3's "The American Western Weekend Winning Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days and whose immediate family members or household members have not won a prize from the Station in the last 30 days. Void where prohibited by law. Employees of Station, WBAP-KSCS Assets, LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. - 2. **Contest Period.** The Contest entry period will begin at **9:00am CT on March 2, 2024** and will **run** through **7:59pm CT on March 3, 2024** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

<u>Text</u>: Listen to the station each day during the Contest Period for any song by Luke Bryan. When the listener hears a song by Luke Bryan, send a text message with the full title of the song, spelled correctly, to 888-787-1963. All entries must be received by 6:59pm CT on March 3, 2024 to be eligible for a chance to win a prize.

Each song will be played a minimum of one (1) time during the Contest Period. Entries must be received by the end of the Contest Period to be eligible to participate in the prize drawing. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.

4. **Winner Selection.** On or about 10:00am CT on February 20, 2024, Station will select five (5) potential winners in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or

failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

- 5. **Grand Prize Winner Selection.** On or about 10:00am CT on February 20, 2024, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 6. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. 8. **Grand Prize.** One (1) prize will be awarded in this Contest. Each winner will receive: two (2) passes to a pre-show VIP experience with the station and Luke Bryan at Globe Life Field in Arlington, TX on March 8, 2024.

The approximate retail value ("ARV") of each prize is One Hundred Dollars (\$100.00).

### TOTAL ARV OF ALL CONTEST PRIZES IS: ONE HUNDRED DOLLARS (\$100.00).

Winner is responsible for all taxes associated with prize receipt and/or use. Odds of winning a prize depend on a number of factors including the number of eligible entries received during the Contest Period and listeners participating at any given time.

Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
