# NEW COUNTRY 96.3'S "Aulani, A Disney Resort and Spa Getaway 4.29 – 5.10" CONTEST OFFICIAL RULES

The Station will conduct the **New Country 96.3's "Aulani, A Disney Resort and Spa Getaway 4.29 – 5.10"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. There will be a total of thirty (30) keywords announced during the Contest Period, with three (3) keywords being announced each weekday during the Contest Period. The winning qualifier will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) day of notification or failure to claim the prize within one (1) day of verification as a winner will result in disqualification and forfeiture of the prize.
